The Certificate of Registration is awarded to “**Jayam Special School, No.16, Mahalakshmi Road, Kalaivanar Nagar, Padi, Chennai-600 050**”, as an Institution for the persons with disabilities vide **Reg.No.231/2022**, under section 51 (2) of the RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016 (Central Act 49 of 2016) to run a **Special School with Hostel for Persons with Disabilities (Intellectually Disabled)**, for Pre-Primary, Primary, Secondary, Pre-Vocational and Vocational Classes. This certificate of registration is valid from 08.08.2022 to 07.08.2025 and is subject to the following conditions:-

1. The Management should run the institution in accordance with Rights of Persons with Disabilities Act, .2016
2. Application for granting renewal of a certificate of registration should be submitted to this office two months in advance before the expiry of the period of validity.
3. The Institution should provide proper barrier free accessible environment & infrastructure facilities including sufficient accommodation. The institution has **58 Male & 09 Female Children only at present**. Based on the infrastructure the **capacity of the institution is fixed at 130 Children** with disabilities.
4. Rain Water Harvesting facilities should be made in the Institution immediately.
5. This certificate should be displayed by the institution in a conspicuous place.
6. The following words may be mentioned in the name board of the Institution “**Jayam Special School with Hostel for Persons with Disabilities (Intellectually Disabled)**, No.16, Mahalakshmi Road, Kalaivanar Nagar, Padi,

Chennai-600 050", is registered under Section 51(2) of the Rights of Persons with Disabilities Act, 2016.

7. i) Structural Soundness Certificate issued by a registered Engineer under sub-section 4 of section 4 of the Tamil Nadu Public Buildings Licensing Act, 1965 (Act XIII of 1965 – **valid up to 07.08.2025**,
 - ii) License issued by the competent authority under sub-section (1) of section 6 of the Tamil Nadu Public Buildings Licensing Act, 1965 Act XIII of 1965) – **valid up to 07.08.2025**,
 - iii) No Objection Certificate from Fire Service Department – **valid up to 23.01.2023**,
 - iv) Sanitation Certificate issued under the Tamil Nadu Public Health Act, 1939 – **valid up to 14.02.2023**,
8. The registration certificate is valid for the period mentioned therein and is subject to the condition that the certificates mentioned in 7 (i) to (iv) above are to be renewed in time before the date of expiry and a copy has to be furnished to the District Differently Abled Welfare Officer of concerned District, failing which the validity of registration made by this office is deemed to be cancelled from the date of lapse of validity of any of the certificate in para 7.
9. The Institution is subject to inspection by the inspection authorities under the Act/Rules and by the persons / officers authorized by the State Government.
10. The certificate of registration is liable to be revoked as per the provisions given in the section 52 of the Rights of Persons with Disabilities Act, 2016.
11. The registration shall be subjected to the conditions laid down in the **RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016** and the rules and order made by the competent authorities.

Under the powers delegated in the G.O.(Ms).No.196, Social Welfare Department, Dated.10.3.1980 & G.O.(Ms).No.220, Social Welfare & Nutritious Meal Programme Department, Dated.17.12.1999, the Certificate of "Temporary Recognition" is accorded to "Jayam Special School, No.16, Mahalakshmi Road, Kalaivanar Nagar, Padi, Chennai-600 050", to function as Special School with hostel for Persons with Disabilities (Intellectually Disabled), for Pre-Primary, Primary, Secondary, Pre-Vocational and Vocational Classes. This certificate of recognition is valid from 08.08.2022 to 07.08.2025 and is subject to the following conditions:-

1. Qualified Teachers appointed in 1:8 ratio should be maintained scrupulously throughout the recognition period.
2. The Management should run the school in accordance with Provisions of the **Tamil Nadu Recognized, Private Schools (Regulations) Act, 1973 and Rules 1974.**
3. Application for granting renewal of a certificate of recognition should be submitted to this office two months in advance before the expiry of the period of validity.
4. The Institution should provide proper barrier free accessible environment & infrastructure facilities including sufficient accommodation. The institution has **58 Male & 09 Female Children only at present.** Based on the infrastructure the **capacity of the institution is fixed at 130 Children** with disabilities.
5. The Management should not appoint any teachers whose certificates have been cancelled or who have been convicted for offence involving moral turpitude.
6. The Management should maintain economic strength prescribed by the Education Department in all the Standards.

7. Rain Water Harvesting facilities should be made in the Institution immediately.
8. This certificate should be displayed by the institution in a conspicuous place.
9. The following words should be painted in the Name Board by the School
"Recognized by Commissioner for the Welfare of Differently Abled, Chennai, as a Special School with hostel for Persons with Disabilities (Intellectually Disabled), Pre-Primary, Primary, Secondary, Pre-Vocational and Vocational Classes.
10. i) Structural Soundness Certificate issued by a registered Engineer under sub-section (1) of section 4 of the Tamil Nadu Public Buildings Licensing Act, 1965 (Act XIII of 1965) – **valid up to 07.08.2025,**
ii) License issued by the competent authority under sub-section (1) of section 6 of the Tamil Nadu Public Buildings Licensing Act, 1965 Act XIII of 1965) – **valid up to 07.08.2025,**
iii) No Objection Certificate from Fire Service Department –**valid up to 23.01.2023**
iv) Sanitation Certificate issued under the Tamil Nadu Public Health Act, 1939 – **valid up to 14.02.2023,**
11. The recognition certificate is valid for the period mentioned therein and is subject to the condition that the certificates mentioned in 10 (i) to (iv) above are to be renewed in time before the date of expiry and a copy has to be furnished to the District Differently Abled Welfare Officer of concerned District, failing which the validity of recognition made by this office is deemed to be cancelled from the date of lapse of validity of any of the certificate in para 10.
12. The School authorities should ensure provision of barrier free and easily accessible environment to the students of Special Schools.
13. The Institution is subject to Inspection by the Inspection authorities under the Act / Rules and by the persons / officers authorized by the State Government. This recognition accorded is valid only, if the school is functioning in the address mentioned in this recognition order.
